1. Activities in 2024.

- An overview of management performance and of accounting records for 2024 was audited by the Audit Committee of the Association through the review of banking records. The management report for 2023 was subsequently sent to the Municipal Court in Prague into a file of documents of the Register of recorded Associations. We were required to file a tax return for 2024. I sent the tax return to the tax office by data message on February 5, 2025. I sent the profit and loss statement and balance sheet for publication to the Municipal Court also on February 5, 2025. We did not incur any tax liability for 2024.
- In 2024 the Association had sent to all 2023 donors for tax purposes a confirmation of the acceptance of their donations.
 In 2024 we have duly accounted for the gift of the Hagibor Foundation for the year 2023. After minor corrections, the billing was sent on February 27, 2024. The Board of Directors of the Hagibor Foundation on September 4, 2024, confirmed the acceptance of the accounts without objections.
- In 2024, we had applied to the Hagibor Foundation for a subsidy of our charitable activities and for the benefit of the Hagibor Social Care Home (DSPH). For 2024 we have applied for a subsidy of CZK 8 million. This contribution is tied to a commitment to properly account for the use of funds provided to the Hagibor Social Welfare Home budget by the end of June 2025. Proper accounting for the gift is a condition for further cooperation with the Hagibor Foundation. The foundation provided us with support in the amount of CZK 12 million for 2024. For 2025, we will ask the Hagibor Foundation for another subsidy in the amount of CZK 12 million.
- All financial operations in 2024 were performed exclusively via bank transfers. The rejection of cash contributions or cash-box money from individual activities reduces the amount of small donations and contributions but keeps operations transparent and clear to members, donors, and for bookkeepers.
- In 2024 all membership dues were remitted.
- In 2024, the Association had successfully continued with the implementation of the Stolpersteine project (memorial stone markers). In 2023 we have successfully placed in Prague about 100 stone markers. We had to postpone the placement of some prepared stone markers as communications with customers were very demanding. We implemented the placement of some stone markers without the presence of the customer and provided online documentation of the placement. Through the organization of this project the Association is acquiring new donors and the only expense is the cost of the work of the company that technically assists in the placement of the stone markers and related administration costs. In 2024, the project was financially supported with an amount of 80'000 CZK by The Endowment Fund for Holocaust Victims. Thanks to this support, we can, based on a contract, pay for a significant part of the administrative work and communications with those interested in placement of the stone markers. Additional support in the amount of 15 thousand--CZK we have received from the City District of Prague 2. The project is regularly supported by Mr. Trevor Sage not only with financial donations, but particularly by promoting the Stolpersteine project and cleaning the stones. Information about the placed stone markers is continuously being updated on <u>www.stolpersteinecz.cz</u>. For upcoming years we have interested parties for more than two hundred memorial stone markers.
- The cost of Stolpersteine consists of:
 - a) Expenses for the paving company laying Stolpersteine. Using a professional company is a requirement of the Technical Communications Management authority (TCM).
 - b) Ongoing communication with all interested parties, registration of interested parties, assistance in searching for identification of names (of places), places of last residence, endless communication about the logistics of the entire project, final specification of ordered Stolpersteine, preparation of documentation for requests for permit determinations from the TCM, the Municipality, statements for the media and finally participation in the process of Stolpersteine placement.

- In 2024, we had realized three benefit events. These included visits to the **Czech Aviation Training Centre at the airport**, a tour of the Hotel Grad Hotel International with the Alma Rosé theatre performance, and a tour of the Czech National Bank. The events were extremely interesting and financially successful, with participants contributing CZK 253,500 to the Association.
- In 2024, we successfully continued our activities to support the activities of the Hagibor Social Care Home. The result is significant donations to support the activities of the Hagibor Social Care Home.
- 12. prosince se uskutečnila výroční členská schůze Veřejně prospěšný spolek na podporu osob dotčených holocaustem. Prezenčně se účastnilo 12 členů spolku a 4 členové se účastnili jednání on-line, 1 člen na základě plné moci. Schůze se účastnili předseda správní rady Nadace Hagibor, ředitel Domova sociální péče Hagibor, ředitelka Domácí péče EZRA, zástupce Rafael institutu, zástupce Nadace Hagibor a tajemník Židovské obce v Praze. Schůze projednala návrh výroční zprávy, přijetí a poskytnutí darů pro sociální a zdravotní služby, daru pro Nadační fond obětem holocaustu a Rafael institutu.
- On December 12, the annual membership meeting of the **Public Benefit Association for the Support of Persons Affected by the Holocaust** took place. **12** members of the association participated in person, 4 members participated online, and 1 member by proxy. The meeting was attended by the chairman of the board of directors of the Hagibor Foundation, the director of the Hagibor Social Care Home, the directress of EZRA Home Care, a representative of the Rafael Institute, a representative of the Hagibor Foundation, and the executive director of the Jewish Community in Prague. The meeting discussed the draft of the annual report, the acceptance and the granting of donations for social and health services, and donations to the Endowment Fund for Holocaust Victims and the Rafael Institute.
