Annual Activity Report of the Association for 2020

Public-Benefit Association for the Support of Individuals Affected by the Holocaust IČ: 03929007, residing at CZ-110 00 Praha 1 – Staré Město, Malá Štupartská 646/1

1. Activities in 2020.

- An overview of management performance and of accounting records for 2019 was audited by the Audit Committee of the Association through the review of banking records. The management report for 2019 was subsequently sent to the Municipal Court in Prague, into a file of documents of the Register of recorded Associations. The Association informed the Tax Office that pursuant to Section 38mb No. 586/1992 Coll. of the Income Tax Code, it was not required to file an income tax return for 2019.
- In 2020 the Association sent to all 2019 donors for tax purposes a confirmation of the acceptance of their donations.
 In 2020 we have duly accounted for the gift of the Hagibor Foundation for the year 2019. The Hagibor Foundation has confirmed by mail on May 05, 2020 the accuracy of the accounting.
- All financial operations in 2020 were performed exclusively via bank transfers. The rejection of cash contributions or money-boxes during individual activities reduces the amount of small donations and contributions but keeps operations transparent and clear to members, donors, and for bookkeepers.
- All membership fees were duly paid in 2020.
- In 2020, we have not applied to the Hagibor Foundation for a support of our charitable activities or in favor of the Hagibor Social Care Home (DSPH). Due to the pandemic situation, we have applied for a subsidy of CZK 8 million for the year 2021. This contribution will be tied to a commitment to properly account for the use of the provided funds within the budget of the Hagibor Social Welfare Home by the end of September 2022. Proper accounting of the gift will be a condition for a further cooperation with the Hagibor Foundation.
- In 2020, the Association has successfully continued with the implementation of the project Stolpersteine. In 2020, we have successfully placed in Prague 41 stones. We had to postpone the placement of other prepared Stolpersteines because those who ordered them or the relatives were unable to realize their trip to Prague due to the Covid pandemic. By organizing this project the Association acquires new donors and the only expense is the cost of the work of the company that technically helps in placement of the stones. In 2020, the project was financially supported with an amount of 60'000 CZK by NFOH (The Endowment Fund for Holocaust Victims). Thanks to this support, we can based on a contract, pay for a significant part of the administrative work and communications with those interested in placement of Stolpersteine. Information about placement of Stolpersteine is continuously being updated at <u>www.stolpersteinecz.cz</u>. For the years to come we have interested parties for more than a hundred Stolpersteines.
- Due to the limitation of social activities, in 2020 we have managed to implement only a single charity event, a visit to the Saint Vitus Cathedral, which was exceptionally successful.
- In March 2020 we have appealed to our friends and supporters to support the activities of the Hagibor Social Care Home that faced a lack of protective equipment and, in the second half of the year, an absence of employees who were sick.

 On December 9, an annual membership meeting of The Public-Benefit Association for the Support of Individuals Affected by the Holocaust was held. The online meeting was attended by 16 members of the Association and as guests were the director of home care EZRA, a representative of the Board of Directors of the Hagibor Foundation, the director of the Endowment Fund for Holocaust Victims, the Director of the Social Care Home Hagibor and the Executive Director of the Jewish Community in Prague. The meeting discussed the draft of the Annual report, the acceptance and the granting of donations for social and health services and a donation to the Endowment Fund for Holocaust Victims.
